Board of Veterans Appeals

Claims Appeal Process information

- A Veteran or dependent/caregiver has a full year to appeal a denied claim regarding any VA benefit. To appeal, file a Notice of Disagreement with the Administration that denied the benefit
- The appeals process has many stages, and most of the appeals processing and resolutions take place in the Administration that made the initial claims decision

Referral Information

Primary Care

We are hoping to streamline as many SSVF primary care referrals as possible through our Homeless Patient Aligned Care Team (H-PACT). H-PACT is a unique approach to primary care that is designed for veterans who are homeless, or those who have pattern of regularly re-entering the homeless system. It is a smaller clinic located at 777 North Meridian Street in the new Indiana Veterans Center.

For veterans comfortable with primary care at the main hospital, and/or those veterans who may not need the unique environment and care H-PACT provides, veterans can contact **317-988-4090 to speak with New Patient Coordinator** and get scheduled for initial appointment with a traditional clinic at the main hospital. Existing primary care patients can call to schedule through **Patient Response Center at 317-988-1772**.

SUDRP/Mental Health

If veteran is already established in outpatient mental health services (PACC) or substance use disorder treatment (SUDRP), the mental health call line at **317-988-2770** can be used to schedule or cancel an appointment. If veteran is seeking mental health services for the first time, calling primary care provider for consult, or contacting mental health call line directly are both appropriate options.

Transportation

Voluntary Transportation Network (VTN)—A system of transportation operated by volunteers. This service is free of charge and transportation is available on a first come, first served basis to Veterans who do not have available transportation to and from their medical appointments at the VA medical center. Veterans can schedule transportation by calling **317-988-2472**. VTN is staffed Mon-Fri, and VTN operators can assist veteran with transportation through other means as necessary. Typically, reservations need to be made at least a week in advance. Visit <https://www.cirta.us/county-connect/transportation-resources/veterans-transportation-service/> for more information.

VetGo—A service that transports medically challenged Veterans who require a special vehicle such as a wheelchair van or an ambulance. This is known as Special Mode of Transportation. VetGo can be reached at **317-988-3846** for consultation and/or to determine veteran eligibility for this service.

Health Benefits and Eligibility

Two health benefits advisors in the Indianapolis Health Benefits and Eligibility (HBU) office have agreed to be points of contact for healthcare navigators needing to verify a veteran's VA healthcare eligibility status. These POCs are **Greta McKenzie at 317-988-3308** and **Stacy Crawford at 317-988-2977**. Typically, they are in need of veteran's full name, DOB, and SSN when attempting to verify eligibility. There are times when HBU cannot verify eligibility without a DD-214, though this is more rare.

Veteran's Crisis Line

This crisis line is intended for veterans who are in an emotional crisis and/or are experiencing thoughts of harming themselves or others.



Frequently Asked Questions

Q: Must I receive all COMPACT ACT care at a VA facility?

A: You may receive emergency suicide care at a VA or non-VA facility.

Q: What do I do if I receive a bill for emergent suicide care?

A: If you receive a bill for COMPACT related care, please contact your local VA facility patient advocate or the number provided on your bill.

Q: What if I do not agree with the VA decisions made related to emergent suicidal care?

A: If you do not agree with decisions made, please contact your local VA medical center patient advocate.

Veterans Comprehensive Prevention, Access to Care, and Treatment (COMPACT) Act

Information for Veterans

What is COMPACT ACT?

Under the COMPACT ACT, Veterans with acute suicidal crisis can go immediately to any VA or non-VA healthcare facility for emergency health care at no cost. VA will provide, pay, or reimburse treatment, emergency suicidal care, and transportation costs for eligible Veterans.

What is an Acute Suicidal Crisis?

An individual determined to be at imminent risk of self-harm.

What is Emergent Suicidal Care?

Care that ensures immediate safety and reduces the severity of distress, or requires the need for urgent care/emergency intervention

What Services are Available?

COMPACT Act covers the following care at no cost:

- Up to 30 days of inpatient or crisis residential care
- Up to 90 days of outpatient care (includes medical and mental health care)
- Prescription medications
- Emergent suicidal care and emergency transportation

How it Works

For an Acute Suicidal Crisis:

- Call the Veterans Crisis Line at 988 option 1, text 838255; or
- Present to your nearest VA or non-VA emergency room
- Inform staff you are a Veteran
- Notify the VA by calling 1-844-724-7842

For all emergencies:

- Call 911 or present to your nearest VA or non-VA emergency room

Who is Eligible?

Veterans are eligible for emergent suicide care if they are in an acute suicidal crisis and are:

- Veterans discharged from active duty under conditions other than dishonorable after a period of 24 months of active service.
- Veteran who served more than 100 days under a combat exclusion or in support of a contingency operation, either directly or by operating an unmanned aerial vehicle from another location, who were discharged under conditions other than dishonorable.
- Veterans who were the victim of a physical assault of a sexual nature, a battery of sexual nature, or sexual harassment while serving in the armed forces.

Are You Helping a Veteran Who Needs Emergency Treatment for an Acute Suicidal Crisis?

1. If a Veteran is in an Acute Suicidal Crisis, take them to the nearest Emergency Room for care.
2. If taking the Veteran to a community hospital, share this card with hospital staff for instructions on how to access treatment.

This guidance relates to eligible Veterans in acute suicidal crisis having access to initial ambulance transportation, emergency care, related prescriptions, 30-days of inpatient or residential care and 90-days of outpatient care – either in the community or at a VA facility – with no out-of-pocket cost to them. This care is specific to addressing the acute suicidal crisis and authorized by the Veterans

COMPACT Act of 2020.

Fax all records as soon as possible (within 72 hours), to our Bed Management/Interfacility Transfer Coordinator at 317-988-5536. Please ensure medical records have indicated the Veteran presented to your Emergency Room in Acute Suicidal Crisis.

Who is eligible for the SUD Recovery Program (SUDRP)

If you think that you have a problem with alcohol, cocaine, marijuana, opiates or any other drug of abuse, you can get help at the Substance Use Disorder Recovery Program.

How do I get into SUDRP?

Referral from other VA services in the VAMC

Ask your provider to enter a referral for Outpatient services. This can be your primary care doctor, mental health provider, or any other provider at the hospital. After reviewing your chart and the referral, a SUDRP staff member will contact you to schedule an orientation appointment. After orientation, you can begin services by having an intake scheduled.

Inpatient Referrals from VA Medical

A referral can be placed for you while you are in the hospital. A SUDRP staff member will visit you to discuss services and follow-up care planning.

Recovery Approach

SUDRP treatment may involve the veteran in group therapy, individual therapy, case-management, and/or medication management. Each Veteran's recovery plan is made to meet his/her own needs.

Walk in for Detox

If you have not used substances on your usual schedule, and think you are in withdrawal, walk in to the clinic for an evaluation and possibly withdrawal support medications, if they are appropriate. This will get you started as a self-referral.

SUDRP Programs and Services

Intensive Outpatient Program (IOP):

(You need to be evaluated and be referred to these groups *before* attending them. It is also expected that by the second week of IOP a patient will be free of drugs or alcohol.). The IOP program is 6 weeks meeting every Monday, Wednesday and Thursday from 9:00 a.m. to 12:00 p.m. for the day session and 5:00 p.m. to 8:00 p.m. in the evening or 3 hours all 3 days. You will also have individual counseling

support. The number of counseling meetings is based on your recovery needs.

Outpatient (OP):

If you do not need a program as detailed as the IOP, we offer a 12-week Outpatient group. The OP meets Mondays from 9:30 am to 11am or 6:00 pm to 7:30 pm in the evenings or Thursdays from 12:30 pm to 2:00 pm. Individual counseling support is also available in the OP program. You will meet for counseling meetings based on your recovery needs.

-
Aftercare:

This is a 12-week class that is part of the IOP or OP to help you while you develop Sober Support in the community. Time can be extended up to a year. This group meets on Mondays, 9:30 am to 10:30 a.m. or in the evening from 6:00 pm. to 7:00 pm.

Evaluation Only:

Evaluations are done for Veterans as requested by the court system, vocational rehab or the Veteran's employer. Veterans will be required to sign a form so results may be shared with the person or agency asking for the evaluation. We will suggest treatment needed or

NOT needed, based on the evaluation.

Medication Management:

Medications are available to help in recovery. This could be for their substance use disorder and / or for mental health illness due to their substance use. Veterans already involved with mental health clinic can continue being seen in mental health; sometimes transfer of care may occur. After completion of SUDRP treatment, staff will refer any mental health needs or medications for a Veteran back to the mental health clinic or primary care for follow-up.

Outpatient Detox:

Detox services work with people who struggle with alcohol, opiate or benzodiazepine addiction. These services can be had as walk-in or by scheduling an appointment. Walk-in patients can have wait times while staff takes care of Veterans with *scheduled* appointments. **If having serious withdrawal symptoms, go to the Emergency Department.** For information call Monday through Friday 8:00 a.m. to 2:30 p.m. to speak with the SUDRP RN . ***Inpatient detox is not available for opioid or stimulant withdrawal. These services are strictly outpatient.***

Opioid Substitution (This is NOT for pain management or management of pain medication):

This treatment uses Methadone or Suboxone substitution for Opiate Addiction. After your intake, and meeting with for a nursing intake you can

Opioid Substitution group: This group is for Veterans needing support while on Methadone or Suboxone. To attend, you need referral by SUDRP staff.

Peer to Peer Support

Veterans have the option of engaging in individual and group peer to peer interventions. A Peer Specialist is someone who is recovering from a substance use disorder and/or mental health condition who has experience with recovery. Peer Specialists are transparent and ready to model and share their coping skill with recovery. The goal of peer to peer work is to promote self-determination, personal responsibility, and empowerment to assist others in regaining control over their own lives and over their own recovery process. We can accomplish this by setting goals, problem solving, symptom management skills, and a variety of recovery tools.

Seeking Safety:

This group is by referral from SUDRP staff for Veterans who have had trauma and need support for emotional and substance use history. Groups are gender specific; women's group takes place Fridays from 11am to Noon and men's group from Noon to 1pm weekly. To get the most, you need to plan to attend regularly.

CBOC Services:

Each community based outpatient clinic offers SUDRP services like the Indianapolis Hospital, **but some services are limited.** Each clinic *can* use Clinical Video Teleconference or VVC to offer more services. Many groups and medication management appointments are offered by CVT. **No medications are kept on site in the CBOCs.** The VA will mail medications as needed. Feel free to ask about services available with the SUDRP CBOC provider in your location.

***Veterans must agree to CVT appointments before scheduling. If the Veteran does not want to use CVT**

or VVC , appointments can be set for an Indianapolis visit to the main SUDRP clinic.

Working with Other VA Programs:

SUDRP works closely with all areas of VA care: medical, mental health, Domiciliary, HUDVASH, and inpatient services. Veterans enrolled in SUDRP services can expect providers to talk with other VA programs to provide active care

Legal Partnerships

- The VJO program also assists to create partnership opportunities for civil legal services to assist Veterans experiencing common issues that impact Whole Health and Wellness.
- The Indianapolis VJP program has partnerships with various legal partners to provide Wills Clinics, Ask-A-Lawyer events, and assistance to avoid eviction specifically for Veterans
- Additionally, the VJP program has a full program to assist Veteran's releasing from the Department of Corrections to support Veterans' Re-Entry into the community. The Health Care for Re-Entry Veterans (HCVR) Program provides prison outreach to Veterans throughout the State of Indiana. The program can provide targeted short-term case-management after re-entry to complex Veterans needing readjustments support.

Veterans Justice Outreach

- The Veterans Justice Outreach (VJO) Program is the Department of Veterans Affairs' (VA) larger effort to address homelessness among the Veteran population experiencing legal matters.
- As homelessness and involvement with the legal system often go hand in hand, the VA has designated staff and resources specifically for this portion of the Veteran population.
- VJO Specialists work with local courts, jails, and law enforcement to identify and engage potential Veterans that would benefit from linkage to VA services and case-management.
- The VJO program is designed to collaborate with local justice system partners to identify Veterans that enter the criminal justice system and are in need of treatment services rather than incarceration.
- VJP specialists help provide case-management and linkage to VA services to a diversity of Veterans with legal needs: probation, court procedures to support progress in addressing legal matters
- The VJO specialist can provide Veterans with legal resources, but they do NOT provide legal counsel or representation.

Veterans Treatment Courts

Veterans Treatment Courts (VTC) were first established in 2008 and continue to grow. The current VTC's affiliated with the Indianapolis VAMC include:

- Bartholomew County VTC
- Greenwood City VTC
- Hamilton County VTC
- Indianapolis VTC
- Montgomery County VTC
- Monroe County VTC
- Lawrence County VTC
- Tippecanoe County VTC
- Vigo County VTC

A unique component of the VTC, is the Mentor Program. Some courts are able to match participants with *trained* mentors. The mentor provides additional support to VTC participants.

VTC's consists of an interdisciplinary team that typically include:

- Judge
- Defense Attorney
- Prosecutor
- VJO Specialist
- Probation/VTC Case Manager
- Community Corrections
- Non-VA community MH/Addictions provider

Referrals to VTC typically come from within criminal justice system.

Veterans Legal Clinic

According to a recent survey, 5 of the top 10 unmet needs for homeless veterans were legal needs including:

- Eviction/foreclosure issues
- Child Support Arrearage
- Restoring driver's licenses
- Discharge upgrades

Additionally, civil legal matters can create barriers to housing and employment.

The Roudebush VA Medical Center Legal Clinic provides pro-bono guidance in addressing these challenges.

The Legal Clinic is held the SECOND Tuesday of each month in room C1202 from 11am-4pm. Please arrive by 3pm to be seen that day.



Employment in Recovery

- ◆ Research has shown the importance of employment in mental health and life satisfaction with working up to 8 hours/week (Kamerade et al., 2019)
- ◆ The benefits of working for individuals with mental health symptoms include improved self-esteem, life satisfaction, global well-being and lower risk of hospitalizations (Luciano et al., 2014, 2016)

Community Based Employment Services (CBES)

- ◆ Community Based Employment Services (CBES) is a program for Veterans with mental or physical health barriers who have a history of sporadic employment, difficulty maintaining a job, or initiating and following through on their job search
- ◆ CBES provides a range of support services including resume development, rapid job search, job application, etc. leading to competitive employment
- ◆ VR Counselors provide ongoing support to Veterans and employers for employment maintenance
- ◆ CBES is an evidenced-informed practice

Vocational Assistance

- ◆ Vocational Assistance is designed to provide brief vocational counseling and guidance to Veterans who are capable of independent job searches to return to competitive employment
- ◆ Vocational Assistance may include the following services: resume and job seeking skills assistance, translation of military skills to civilian occupations, career counseling, and referrals to community resources as needed

Supported Employment (SE)

- ◆ Supported Employment (SE) is intended for Veterans with significant barriers to employment due to serious mental illness
- ◆ SE assists Veterans with obtaining meaningful employment and provides ongoing support to assist with maintaining employment
- ◆ SE support services include rapid job search, job development and placement, continued engagement and follow-along supports (once employed)
- ◆ Veterans will work with their counselor to develop a treatment plan based on their individual employment goals
- ◆ SE is an evidence-based practice for individuals with serious mental illness

Transitional Work (TW)

- ◆ The goal of Transitional Work is to provide vocational supports and resources needed for a Veteran to successfully transition to competitive employment
- ◆ Veterans participate in worksite placements at the medical center and/or in the community (when appropriate/available) after completing initial vocational counseling and treatment
- ◆ Veterans develop a treatment plan and engage in treatment to reduce barriers to employment, meeting with their VR Counselor at least twice/month to evaluate their progress and goals
- ◆ A tax-free stipend is provided to Veterans while in a worksite placement, however the stipend may be considered income for outside agencies
- ◆ Veterans learn how to reduce their barriers to employment through weekly group meetings with their peers
- ◆ Veterans will begin their job search activities towards the end of their worksite placement

Career Center

- ◆ Access to computers for resume and cover letter development, online job searching, email communication with employers, etc.
- ◆ Copy/Scan/Fax available for use related to employment purposes
- ◆ Tutors in Career Center may be available to provide general guidance regarding computer use
- ◆ Career Center Tutors are not VA Medical Center employees

2021 Performance Data

- ◆ 70.9% of Veterans enrolled in Community Based Employment Services achieved their employment goal
- ◆ 62.5% of Veterans enrolled in Supported Employment Services achieved their employment goal
- ◆ 37% of Veterans enrolled in the Transitional Work program achieved their employment goal

Intimate Partner Violence (IPV)

WHAT IS INTIMATE PARTNER VIOLENCE (IPV)?

Intimate partner violence (IPV) occurs when a current or former intimate partner (for example, boyfriend, girlfriend, spouse) harms, threatens to harm, or stalks their partner/former partner.

EMOTIONAL IPV

Emotional IPV is when a person tries to hurt their partner emotionally and mentally. It is common for emotional IPV to begin before other types of IPV.

Examples include:

- Name calling, putting you down
- Controlling your money or spending
- Keeping you from friends and family
- Bullying, stalking
- Controlling where you go or what you wear

PHYSICAL IPV

Physical IPV is when a person tries to hurt their partner by using physical force.

Examples include:

- Hitting
- Slapping
- Choking
- Biting
- Shoving
- Kicking
- Restraining
- Hair-pulling

SEXUAL IPV

Sexual IPV is when a person forces or tries to convince their partner to engage in sexual activities when the other partner does not want to, or is unable to consent (for example, when someone is impacted by alcohol or drugs).

THREATS OF VIOLENCE

Threats of violence are ways to cause fear through words, actions, or weapons to harm the partner, their possessions, their pets, or their loved ones.

Some people experience only one of these forms of violence while others may experience more than one. IPV can be a single event or can last for many years. No matter what, no one deserves to be treated this way.

WHAT ARE THE EFFECTS OF IPV

MENTAL HEALTH

- Sadness
- Feeling “on edge”
- Difficulty concentrating
- Trouble relaxing
- Being stressed out
- Trouble sleeping
- Nightmares
- Feelings of shame or guilt
- Blaming yourself for what happened

PHYSICAL HEALTH

- Pain
- Headaches
- Pregnancy complications
- Stomach problems
- Bruises/cuts
- Broken bones
- Fatal injuries
- Female health problems

SOCIAL HEALTH

- Avoiding new relationships
- Feeling uncomfortable or unsafe in relationships
- Money problems
- Difficulties trusting people
- Pulling away or isolating from friends and family
- Homelessness
- Job issues

MANY PEOPLE WITHIN VA CAN HELP YOU GET SERVICES

Contact your local VA clinic and ask to speak with a social worker or the Intimate Partner Violence Assistance Program Coordinator.

VA employees who are impacted by IPV can also contact the IPVAP Coordinator.

VA can provide community referrals for things such as legal advice, shelters, and support groups.

Talk to your primary care provider and they can refer you to a mental health specialist, such as a social worker or psychologist.

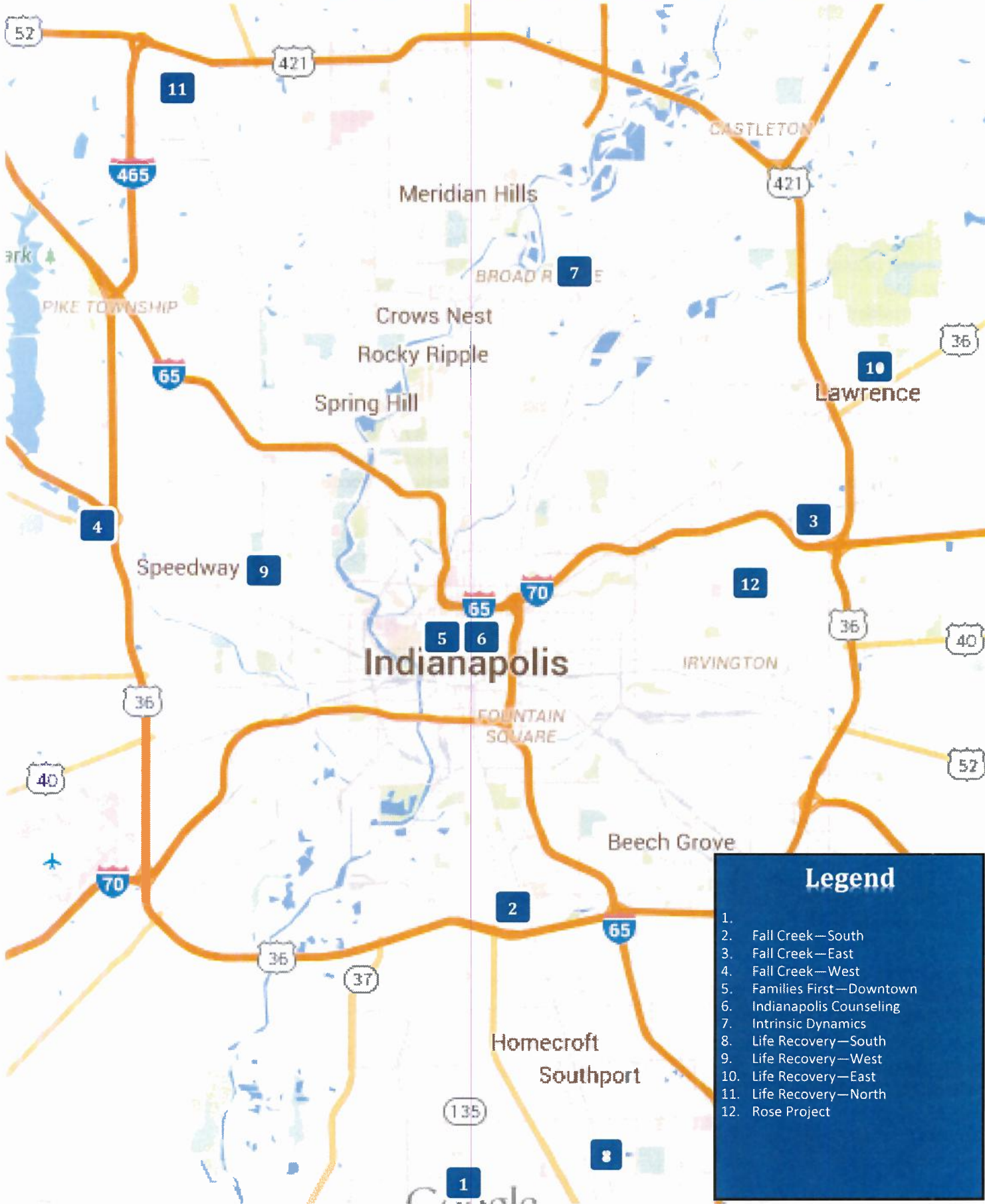

CADHC can be used in combination with other Home & Community Based Services.

Community Action of Greater Indianapolis (CAGI'S) PRESCRIPTION ASSISTANCE PROGRAM

How will it help participants?

Allowing the patient to receive their medications without having to pick between purchasing their medicines or their mortgage, rent payment, utilities, or even food.

Who is it for?

Anyone who pays \$10 or more per month for their prescribed medication(s).

How does it work?

CAGI has access to Prescription Assistance Programs offered by all nationally pharmaceutical manufacturers. You are invited to fill out an application for your prescribed medications to be given freely or at a very low price.

After the application is submitted to CAGI, Wonda Smith will communicate to you if the pharmaceutical manufacturer has an assistance program for your medication and has accepted your application.

- 1.) Fill out the form. The application form will be on the CAGI website, or CAGI will have printed application forms at the CAGI office located at 3266 N. Meridian St. Indianapolis, IN 46208.
- 2.) Submit the form to CAGI.
- 3.) CAGI will contact you back with any questions, notice of approval, or notice of unapproved from the pharmaceutical manufacturers
- 4.) If approved, a signature page is needed to be signed by the participating patient.
- 5.) A copy of the written prescription is needed.
- 6.) If approved, **the medication will either be shipped to your home, pharmacy, clinic, or hospital. Never will your medications be shipped to CAGI.**

Where will I get my medication?

If approved, the medication will either be shipped to your home, pharmacy, clinic, or hospital. Never will your medications be shipped to CAGI.

What is the process to apply and timeline?

On the CAGI website is a form to apply for the Prescription Assistance Program to receive your prescribed medications freely or at very low cost from the pharmaceutical

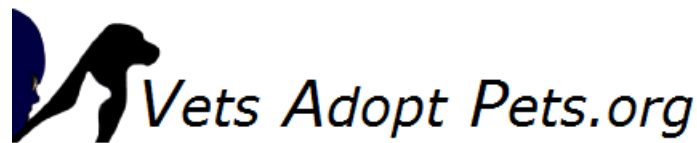

It is an honor to thank you in this manner and do so because we believe the pet will bring much love, fun and companionship into your life for years to come. So if you can allow yourself to be thanked in this manner, please 'take' it.... it is given with sincerity. Vets Adopt Pets is funded by everyday Americans across the country that thank you for your service with their donations. We provide 1 pet per Veteran/ActiveDuty.
- ★ Once you are signed up with VetsAdopt Pets, we will attempt to work with your local county shelter to handle the financials of the adoption fee and to see if they will let you take the pet home while we take care of their fee. In some cases, you will need to pay the adoption fee then send us the paid receipt and we will reimburse you. Please note in certain parts of the country there are no county pet shelters and the subcontracting rescue fees are too high for us to cover. OR if you just want to pay the fee and avoid the delay of my involvement, send a copy of your receipt for reimbursement.

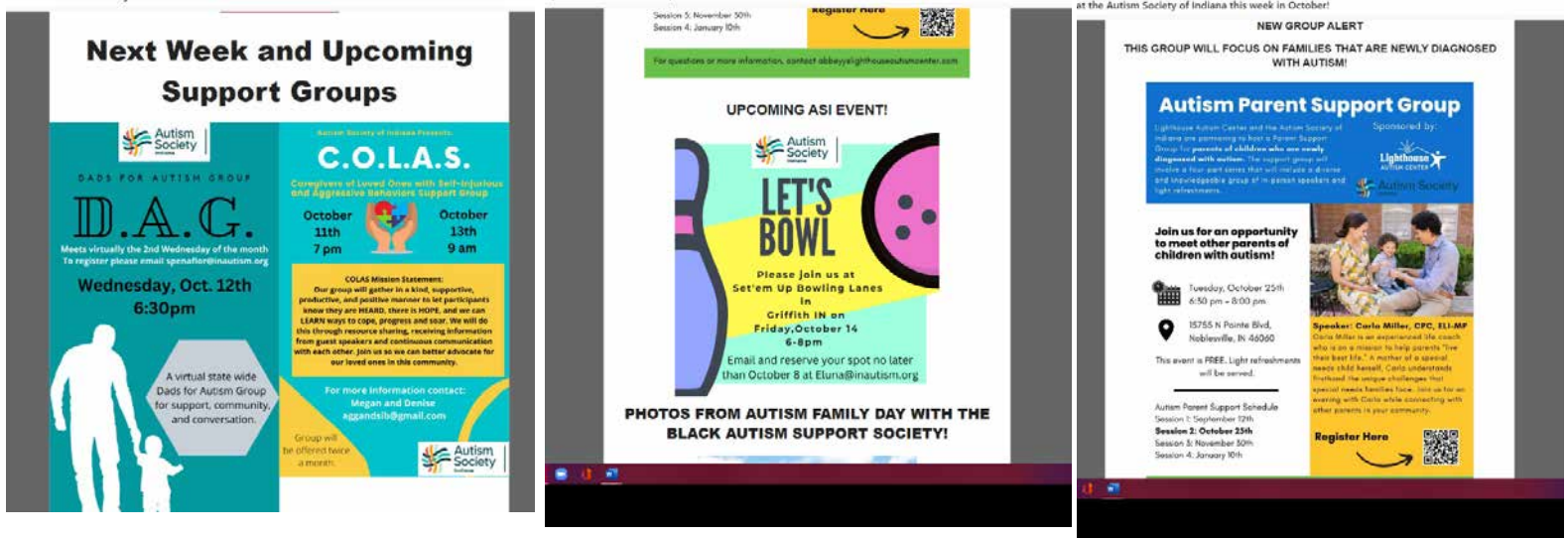

About the Family Supports Waiver



Division of Disability and Rehabilitative Services
Bureau of Developmental Disabilities Services

The Medicaid Home- and Community-Based Services Waiver program provides person-centered individualized supports that assist children and adults with intellectual and developmental disabilities to live successfully in their home and community. The Family Supports Waiver is one of two of the Indiana Medicaid Home- and Community-Based Services administered by the Bureau of Developmental Disabilities Services.

Am I eligible?

To qualify for the Family Support Waiver, a you must have been diagnosed with an intellectual disability, developmental disability or related condition with an onset prior to the age of 22 years and the condition must be expected to continue indefinitely.

Additionally, you must meet Level of Care. This means that the child or adult has substantial functional limitations in at least three of six major life areas: self-care, learning, self-direction, capacity for independent living, understanding and use of language, and mobility.

You must also meet the requirements of eligibility for a compatible Medicaid category.

If you are under the age of 18 years, household income eligibility requirements for Medicaid are not considered and only the income/assets of the child is taken into consideration. If the individual/family is requesting Medicaid coverage for the 90 days prior to the Medicaid application date, then household income eligibility requirements are taken into consideration.

If you are age 18 years and above, you must apply and be found eligible for benefits from the Social Security Administration.

What types of services does the Family Support Waiver provide?

The Family Support Waiver offers a range of services that are chosen based upon person-centered principles and are to be delivered in the home and community settings by an approved Medicaid provider. The current maximum budget is \$17,300 per person, per year. Current services include:

Is there a waitlist?

It is the policy of the Bureau of Developmental Disabilities Services that individuals may be placed on a single statewide waitlist after applying for waiver services and meeting Level of Care criteria. Individuals will be targeted in the order they applied for services, from the oldest date of application to the newest.

You and your guardians are responsible for ensuring that personal contact information is kept up to date with your local BDDS office. You and your family can review and update your contact information and waiver application dates by visiting the BDDS Waitlist Web Portal at www.in.gov/fssa/ddrs/4328.htm or by contacting your local BDDS district office.

What is Priority Criteria?

Priority criteria allows the following individuals to obtain the Family Support Waiver without being placed on the waitlist:

- Adults ages 18 through 24 who have aged out of, graduated from or have permanently separated from their school setting
- Dependents of military active duty members and veterans

How do I apply?

You or your guardian may apply for the Family Support Waiver by contacting your local Bureau of Developmental Disabilities Services office for an application packet. Applications can also be printed at www.in.gov/fssa/ddrs/3349.htm. Forms needed as part of the application are the Application for Developmental Disabilities Services (State Form 55068) and Confirmation of Diagnosis (State Form 54727). Applications may be submitted by mail, fax or in person to the local BDDS office. To find your local office, you may call **800-545-7763** or visit www.in.gov/fssa/ddrs/4088.htm. The Bureau of Developmental Disabilities Services staff are available to answer your questions.

Eligibility:

Disability compensation is a monthly tax-free benefit paid to Veterans who are at least 10% disabled because of injuries or diseases that were incurred in or aggravated during active duty or active duty for training. A disability can apply to physical conditions, such as a chronic knee condition, as well as mental health conditions, such as post-traumatic stress disorder (PTSD). If you were on inactive duty for training, the disability must have resulted from injury, heart attack, or stroke. Your discharge from service must have been under other than dishonorable conditions.

How to Apply:

Veteran Service Officers (VSO) will help you write and submit your benefits claims to the VA. They will help you gather information that supports your claim. Once the claim is filed, they will help you track the claim through the system. They can also help file appeals for denied claims.
